The college has a system of making an academic plan drafted by each faculty member and subject-teachers at the beginning of the academic semester. The Principal and the committee members of different committees try their level best to see that the plans made therein are implemented. At the end of the semester, an actual list of events that took place during the semester is also made. The syllabi of all the subjects are prescribed by the university. Each faculty member makes a teaching plan for each subject after the distribution of workload, and lectures are taken according to this plan. The semesters and the examination schedules are followed in accordance with the University. There is a timetable committee functioning in the college which arranges lectures of the faculty members. Each subject is allotted three lectures per week in each class. The faculty members use innovative means to deploy the curriculum effectively. These means include group discussions, powerpoint presentations, OHP slides and practical examples. Films and movies that are related to the subject are also used so as to have a more effective deployment of the curriculum. The faculty members use pictures and story narratives, both on screen and verbally, in order to explain the syllabus in the curriculum. Lecture-notes are given to the students in the classroom as well as in the form of handouts for effective deployment of curriculum. Material in the form of questions and answers is also given to the students to help them prepare for examinations.

F) Context: G) Upon observing that certain students dropped out from third or fourth semester of the college, the reason being lack of finances, the institutions principal decided to establish contact with alumni of the college to provide financial aid to students while undertaking the education as well as for further studies upon graduation. H) Thus, we could help the students by providing financial aid in the form of their fees, to continue with their education. I) The fees of the grant-in-aid colleges are as it is very less, yet certain students coming from rural areas and families where no one had studied at any university, faced challenges with their finances. J) At H. A. College we have an existing scholarship programme for studies abroad, sponsored by our alumnus, Mr. Chirag Patel, a NRI in USA. He also has a NGO named 'Niswarth Children Foundation' and the college has an MOU with the same for providing scholarships to the students. a. Another alumnus Poorvi Dalal also came forward to pay the fees of eligible students. K) The Practice: a. Primarily it is brought to the notice of all the students that such financial aid exists. b. The students with very weak economic background are urged to apply for the same. c. The college receives such a large number of applications that it becomes challenging for the concerned committee to shortlist applicants for the scholarships. d. Among the received applications, the students are scanned on the basis of their performances in the previous semester. e. A final list is prepared, and it is communicated to the selected students, that their fees will be borne by the concerned donor. L) Evidence of Success: a. This has resulted in uninterrupted continuous of the students. b. The main outcome is that the students from economically weaker backgrounds have a feeling of security with respect to their education. c. In the year 2018-19, 14 students benefited from the Poorvi Dalal Scholarship and the Niswarth

Children Foundation paid the scholarship of total 8 students for higher studies. d. Following students—Hetal Sarvaiya, Mitesh Gajjar, and Varsha Balani could successfully complete their post graduate studies and have been placed in various jobs. e. Another outcome of this scholarship programme has been helpful to establish the strong attitude of giving back to its alma matter, among the alumni.

**Best Practice 2:**

- Title of the Practice: Organising Expert Guest Lectures
- A) Objective:
  - a. To be in unison with the vision and the mission of the college to have holistic development of the students
  - b. To provide the students with apt exposure to subjects other than their syllabus.
  - c. To ensure that the students get an opportunity to learn from experts who the students would not have been able to approach by themselves.
  - d. Organising guest lectures also helps in ensuring personal interaction between the students and the experts, resulting in opportunities for networking as well.
- B) Context:
  - a. Ours being a commerce college, all the subjects related to commerce are taught in the syllabus but subjects like environmental awareness, spiritualism, self-defence, gender sensitization, social work, and importance of various languages, are not part of the main curriculum. Thus, to ensure that students receive a well-rounded education, and information regarding these important subjects, it becomes the college's duty to organise guest lectures conducted by experts on these abovementioned relevant topics.
- C) The Practice:
  - a. The college has established different societies, for e.g. the H. A. Gandhian Society the Cultural Committee "Antarnad" NSS, which is a vibrant and active association of the college the women's development cell the placement cell the study circle and NCC.
  - b. Various expert lectures are organised under the auspices of these bodies. These lectures are open for not only the members of the society, but the rest of the student body as well.
  - c. In addition to these, it is ensured that there is an awareness programme organised relating to widely discussed issues like cancer, AIDS, and old age for sensitising the students.
  - d. The list of the programmes conducted during 2018-19 is attached herewith.
- D) Evidence of success:
  - a. The students could tap their area of interest, while listening to the experts.
  - b. As a result of one such lecture, students came forward to voluntarily work for social outreach programmes and the college was able to organise a visit to the municipality run school in the vicinity of the college.
  - c. The NSS students who organised a one-week camp at a nearby village, Ropada, visited the same village to continue their social work.
  - d. A large number of students felt motivated to prepare and appear for the civil services examinations after interacting with a few guest lecturers.
  - e. The fact that these lectures organised by these societies are open for all is conducive to interest generation among the entire student body, and not only the members of these societies.
  - f. No difficulty is faced while organising these lectures because it had become an accepted and adopted pattern at our institution.
