Memorandum of Understanding

for

An Agreement of Cooperation

between

**New Jersey City University** 

and

HA College of Commerce, Ahmedabad

In order to develop a mutually beneficial international cooperation and to strengthen academic exchange between HA College of Commerce, an undergraduate commerce college located in Ahmedabad, India, and New Jersey City University (NJCU), a public institution of the State of New Jersey, located in the United States of America, HA College and NJCU agree to the following provisions:

# Article 1: Objectives

The two institutions will endeavor to establish academic exchanges and cooperative relationships. Within the framework of this agreement, the two institutions will explore cooperation in the following areas:

- A. academic study and research opportunities; practical training assignments for students
- B. student exchange
- C. exchange of academic material and information regarding programs of study, conferences, and other professional activities;
- D. exchange of professors, faculty members and other colleagues to teach, collaborate in research and publication, and engage in other professional activities;
- E. collaboration in any other way that is considered mutually beneficial.

These exchanges are established in order to extend the participants' theoretical knowledge and practical experience and also to increase their respect for the language, culture and professional environment of the host country. Each institution shall adhere to its mission statement and accreditation guidelines.





# **Article 2: Faculty Exchanges**

- A. Each party will encourage its staff members to visit the other party to teach or research as a visiting scholar.
- B. The host university will endeavor to provide appropriate assistance to Visiting Scholars during their stay.

## **Article 3: Delegation Visits**

On the basis of equality, both institutions will facilitate short visits between the two organizations. This includes hosting delegations of senior administrators and faculty members, who will travel at their own expense.

## Article 4: Student Exchange

Both institutions agree to explore student exchange programmes between the two institutions. The specific aspect of the arrangement will be clarified by a separate agreement.

#### **Article 5: Contact Person**

Both institutions also agree to designate a contact person from their International Offices, who will communicate with each other and visit each other's campuses as and when necessary to develop the specific parameters for collaboration.

### Article 6: Term

This agreement is valid for a period of three years, after which the institutions may mutually agree to extend the agreement. Either institution may terminate the agreement at any time, with or without cause, without any obligation to each other, with three months' prior written notice to the other institution. The parties understand that New Jersey City University must adhere to all policies and procedures of the University and the State of New Jersey in the implementation of this agreement and in agreements which may be entered in furtherance of the intentions described in this agreement. The parties also understand that H.A. College of Commerce must adhere to the policies and instruction of Gujarat University, to which it is affiliated, and Gujarat Law Society, which is its management.
